The organization offers information, support, and hope for all pregnant and new moms who have postpartum depression and all other mental illnesses related to pregnancy and childbirth, including anxiety, OCD, depression or anxiety during pregnancy, post-adoption depression, PTSD, depression after miscarriage or potential loss and psychosis.

Awareness - Online - Our blog reached 2.6 million page views, a 63% growth over the previous year, and our Facebook fans grew to 22,000, a 38% increase. We also launched our Instagram account in 2015 and reached 1,300 followers by the end of the year. Offline - We held our 3rd annual Climb Out of the Darkness(R), the world's largest event raising awareness of perinatal mood and anxiety disorders. We had more than 2500 Climbers and they raised \$240,000, a 44% growth over the previous year. We worked with the National Institute on Child & Human Development to consult on and provide patient focus groups for a national PPD awareness campaign they are developing. We launched a free ordering system for our patient information materials, and received orders from people in 39 different states as well as the UK and Canada -- more than 26,000 of our Hugs cards were distributed. Our free downloadables were also downloaded more than 3,000 times in 2015. 82% of those ordering our materials said they would be distributed at least partially to minority and underserved women.

Training and Education (ET) - We planned and hosted the first-ever patient-centered conference on perinatal mood and anxiety disorders, the Warrior Mom(R) Conference, in Boston with more than 100 attendees. We also secured a partnership with the National Council on Behavioral Health to begin training all our volunteers in Mental Health First Aid.

Patient Support (PS) - Our private support forum for pregnant and new moms with perinatal mood and anxiety disorders on Smart Patients grew to more than 3,000 members. We also secured a partnership with digital health technology company Iodine to test an app called Smart that tracks the effectiveness of newly prescribed antidepressants for women with PPD.
